JUDGMENT  
(Bench Probation)

THIS MATTER came before the Court for sentencing on March 12, 2010, the defendant having previously been charged with the crimes of Strangulation (Count 1), Assault in the Fourth Degree (Count 2), Assault in the Fourth Degree (Count 3), Harassment (Count 4), and Harassment (Count 5). The defendant has been found guilty of the crime of **Harassment (Count 5)** by plea on March 12, 2010, and the Court has accepted such plea.

IT IS HEREBY ADJUDGED and entered that the defendant, Lamichael Keondrae James, whose date of birth is October 22, 1989, is convicted of **Harassment (Count 5)**. The defendant waived passage of two days before sentencing. This being the time fixed for sentencing, the State appeared through **William E. Warnisher**, Assistant District Attorney, and the defendant appeared personally and through counsel **Michael J. Buseman**. Each party having been given the right to be heard, these proceedings having been reported by Eileen Sterns, Official Court Reporter, and the Court being fully advised;

IT IS HEREBY ORDERED that the Defendant shall pay to the Clerk of the Circuit Court the amounts set forth in the Money Award section which follows, and in the manner specified, which section is hereby made a part of this Judgment.

**Count 5 -- Harassment**

IT IS FURTHER ORDERED that the defendant is sentenced to probation to the Court for the crime of Harassment for a period of **24 months** subject to the terms and conditions set forth below and hereby made a part of this Judgment:

1. Defendant shall violate no law and shall report to the court **in writing** every citation or arrest on any new crime or major traffic offense within five days after citation or arrest. Correspondence should be mailed to: Lane County Circuit Court, 125 East 8th Avenue, Eugene, Oregon, 97401, and all correspondence should include the case number 22-10-03585.

2. Defendant shall keep the Court informed at all times **in writing** of any changes in name or residence address within five days. Correspondence should be mailed to: Lane County Circuit Court, 125 East 8th Avenue, Eugene, Oregon, 97401, and all correspondence should include the case number 22-10-03585.

3. Defendant shall pay the Money Award in full. If a payment schedule is specified in the Money Award, defendant must make payments according to that schedule. Payments should be mailed to: Lane County Circuit Court, 125 East 8th Avenue, Eugene, Oregon, 97401, and all correspondence should include the case number 22-10-03585.

4. Defendant shall serve a period of **10 days** in the custody of the Lane County Supervisory Authority, with credit for time served. The defendant may be considered, at the discretion of the Supervisory Authority, for all alternative programs. The Lane County Supervisory Authority shall retain custody over the defendant until all **10 days** have been served. No further order of the court shall be required to compel completion of this obligation. Defendant shall report to Lane County Adult Corrections, 101 W. 5th Avenue, Eugene, Oregon, no later than 4:00 p.m. on **Friday, March 12, 2010**, to make arrangements for confinement which shall begin at a date and time directed by the Supervisory Authority. All jail time must be completed on a schedule directed by the Supervisory Authority. Defendant shall pay, as directed, all fees assessed for participation in programs as an inmate.

5. Defendant shall report in person not later than 2:00 p.m. on **Thursday, April 1, 2010** to the Center For Family Development (CFD), 1234 High Street, Eugene, Oregon for a domestic violence evaluation. Defendant shall comply, at defendant's expense, with all evaluation, treatment and education programs designated by CFD or by any other agency to which defendant is referred by CFD or by the Court. Treatment may include monitored Antabuse or other medication, if recommended by any such agency and medically prescribed, and in-patient and out-patient treatment. Defendant shall authorize each such agency **in writing** to release to the Court and CFD complete information regarding defendant's evaluation, performance or non-compliance.

6. Defendant shall have no contact of any kind with Heidi Lee Siebenlist.

IT IS FURTHER ORDERED AND ADJUDGED that the following counts are dismissed as to the Defendant pursuant to negotiations: **Strangulation (Count 1), Assault in the Fourth Degree (Count 2), Assault in the Fourth Degree (Count 3), and Harassment (Count 4).**

Thereupon the Court advised the defendant of the rights of appeal.

#### **MONEY AWARD**



Defendant shall pay the Money Award in full not later than March 15, 2010. Payments should be made in person or mailed to: Lane County Circuit Court, 125 East 8th Avenue, Eugene, Oregon, 97401. All correspondence should include the case number 22-10-03585.

Pursuant to ORS 1.202, a fee of not less than \$50 and not more than \$200 shall be added to any judgment in which the court gives the defendant a period of time to pay the financial obligation imposed. An additional collection fee will be imposed on all cases referred to a collection agency. Both fees will be imposed without further notice from the Court.

Subject to amendment of a judgment under ORS 137.107, money required to be paid as a condition of probation remains payable after revocation of probation only if the amount is included in the money award portion of the judgment document, even if the amount is referred to in other parts of the judgment document.
