
COUNT 1

From on or about September 4, 2005, until in or about October, 2009, in the Eastern District of Louisiana and elsewhere, the defendant, **JEFFREY LEHRMANN**, having knowledge of the actual commission of a felony cognizable by a court of the United States, did conceal the same from law enforcement and did not as soon as possible make the illegal activity known to a judge, agent, or other person in civil or military authority under the United States.


Specifically, the defendant, then a police officer with the New Orleans Police Department, knew of a conspiracy among police officers to obstruct justice, in violation of Title 18, United States Code, Section 1519, and to engage in misleading conduct, in violation of Title 18, United States


Code, Section 1512(b)(3), during the investigation of a police-involved shooting that occurred on the Danziger Bridge in New Orleans on September 4, 2005, and the defendant concealed the conspiracy and participated in the creation of false reports and the provision of false information to investigating agents; all in violation of Title 18, United States Code, Section 4.




