That from on or about July 15, 1998, to July 14, 2000, both inclusive, in the County of Davison, State of South Dakota, Ronald Arthur Dahme committed the public offense of Third Degree Rape (Class 3 Felony), in violation of SDCL 22-22-1(5), in that Ronald Arthur Dahme, who was at least three years older than the victim, committed an act of sexual penetration with any person, to-wit: [REDACTED], who was ten years of age, but less than 16 years of age, to-wit: 14 to 15 years of age, dob [REDACTED]/84;
