Description of Violation to Include Date, Time, Location, Witnesses & Facts: On 070208, at approximately 0713 hrs., Dep. Powell makes a traffic stop on Deans Bridge Rd. in car T-4. The video camera is used. After the traffic stop, Dep. Powell leaves the camera on the microphone inside the vehicle is still on. Dep. Powell receives a phone call on his cell phone. The entire conversation on Dep. Powell's part is recorded, lasting approximately 15 minutes. Dep. Powell uses profanity, sexual comments and racial slurs during the conversation that is recorded by the video equipment. The conversation was discovered on 091608, by the Solicitor General's Office when the DVD, marked Dep. Wesley Powell, DVD #19, was being played for a defense attorney. The conversation, file number DWQ2XD00M was played at that time. It was then brought to the Sheriff's Office attention.





Description of Violation (date, time, location, witnesses, nature of misconduct, etc.):

On Tuesday, January 8, 2002, Deputy Powell went to the Richmond County Jail at 401 Walton Way with a civilian (Steve Bay). The civilian was attempting to have a Social Security check endorsed by an inmate (Arvin Grindle). The civilian did not have any identification, and Deputy Powell provided his drivers license. Deputy Powell also advised Central Control Officer Dianne Cross that he was employed at the "jail on Phinizy Road." When the check was presented to the inmate, the inmate refused to endorse it. The check was placed in the inmate's property. Deputy Powell and the civilian were escorted to Captain Johnson's office, where Deputy Powell was notified that this was a violation of department policy. In addition to RCSO R & R 8.3, the Jails Operations Manual states in Chapter 1, Section 3.2.05 the following: "Jail employees are prohibited from loaning, borrowing, trading, selling, or exchanging privileges for money or merchandise with any inmate. **Jail employees will not become involved in any money transaction with any inmate.**"
