OFFICIAL RULES

HOW TO ENTER: No Purchase necessary. Void where prohibited.

Contest runs from 10pm, Monday, April 28, 2008 through 10 pm, Monday, May 25, 2008, and will be promoted on WSYM-TV FOX 47.

Each weeknight of the contest on FOX 47 News at TEN (10pm) on WSYM-TV Fox 47, an animated Free Livin Icon and MSUFCU Visa Card will appear between 10pm and 11:00pm. Viewers will have 24 hours to log onto www.fox47news.com and enter the Free Livin' Icon as indicated in the on-screen animation.
