IN ANTICIPATION OF A NEW COUNTDOWN REQUIREMENT, AND IN ORDER TO ENSURE OUR VIEWERS ARE PREPARED FOR OUR TRANSITION IN JUNE, WE BEGAN RUNNING COUNTDOWN REMINDERS AGAIN ON MARCH 12, 2009.
