

I, along with members of the Lee County Sheriff's Office, was assigned to the Sobriety Checkpoint on 01/24/09 at 7070 College Pkwy, Fort Myers, Florida. My role was that of a Field Interviewer. As a vehicle traveled into the checkpoint area I would make contact with the driver and explain that we were conducting a Sobriety Checkpoint.

At approximately 0201 hours on 01/24/09, I came into contact with the driver of a White, [1999, [Mercedes]]. The driver was later identified as Leon Young. It was during my contact with the driver that I observed the following:

The defendant before entering the check point area had tried to avoid it by entering the adjacent north parking lot of Val-Ward Cadillac. I then made contact with the defendant/ driver and could see that he had a very dazed and confused look about him and was slumped down in the seat. The defendant's eyes were blood shot and watery and he was speaking with a thick tongue. I could also smell a moderate odor of an alcoholic beverage coming from his breath when he spoke. When I requested the defendant's drivers license he began to fumble through his wallet and then handed me a work identification card. When I asked the defendant if he had been drinking he stated that he had a couple of drinks earlier. I also observed what appeared to be a green leafy substance on the front of his shirt, which had the appearance of marijuana. Canine narcotics units from the Lee County Sheriff's Office were on scene and conducted a free air search of the vehicle and gained a positive alert to the presence of narcotics in the vehicle. A search of the vehicle was conducted by LCSO deputies and no narcotics were located.

Based on the observations, I requested and the driver agreed to participate in a number of field sobriety exercises. The defendant was very reluctant to cooperate stating just take me to jail. After several attempts to explain to him that this was the only way we had to determine that he was not under the influence he agreed to take the standardized field sobriety exercises. I then escorted the driver over to Ed Sommers, who is trained in administering Field Sobriety Exercises. For exercise results, see the Alcohol Influence (Continued)
