

Denney the night prior had not been totally accurate. The victim had related to her father that she had in fact been to the residence of the suspect on two separate occasions and had been in touch with the suspect by phone on numerous occasions. The victim further related that she had been in the company of the suspect unknown to her parents on these occasions. The victim related to her father that she had in fact been to the residence of the suspect and that while there he had attempted to have sexual intercourse with her but he could not obtain an erection. The victim further related that the suspect had attempted to have sexual intercourse with her on a separate occasion on a gravel road along Missouri Hwy Y in St Robert inside her vehicle however he could not get an erection on this occasion either.

On the afternoon of 01-18-08 Sgt Denney conducted a second interview with the victim at her request which was audio taped in the presence of her mother and with the consent of her mother. During the interview the victim related that she had in fact been with the suspect on three separate occasions where the suspect had attempted to have sexual intercourse with her. The first incident was the night of 20 November 2007, the victim related that she had been in telephonic contact with the suspect then later met him in the parking lot of Road Ranger Truck port at the intersection of Missouri Highway 28 and South outer road. The suspect had the victim follow him to his residence and invited her inside the residence described as a cream in color mobile home. Upon entering the residence the victim related that they had looked at some photographs which had been enclosed in a book the suspect had related that his mother had made for him. During the time that the two were at the residence the victim related that the suspect stated that he needed to use the restroom. The victim related that upon his return to the living room area that he was dressed in only his boxer shorts. The victim was asked if there had been any indication prior to the suspects' departure from the room that he wanted to have sexual intercourse with her or that she had agreed to have sexual intercourse with him. The victim related that there had been no conversation or discussion relating to having sexual intercourse or even the fact that the suspect wanted to have intercourse with the victim. The victim related that the suspect approached her and had attempted to put his hand underneath her shirt in what she believed was an attempt to touch her breasts, however she was able to stop him prior to his hand reaching her breasts. The victim related that the suspect removed her pants and had lain on top of her. While the suspect was on top of her he was moving his private area in an attempt to gain entry into her but was unable to get erect. The victim related that the suspect had made a statement to the effect that he was uncertain why he was unable to become erect other than the fact that he was nervous. The victim put her clothes back on and departed the residence. The victim related that during the time that she was at the residence that her cellular phone had rang several times and she later discovered that it was her mother attempting to call her.

The victim related that between the first and second incident that the suspect had called her several times and had even made contact with her inside the building of the Waynesville High School. The victim finally agreed to meet with the victim at his residence a second time. The victim was unable to recall the exact number of days between the first and second incident.

The victim related that on the occasion of the second incident that she had driven herself to the suspects' residence and that upon arrival the suspect had stated that he needed to take a shower. The victim related that she had been lounging on the suspects' bed while waiting for him to complete his shower. When the suspect exited the bathroom he was dressed in only a towel and approached her on the bed. The suspect had kissed the victim in the area of her neck and once again removed the victims' pants. The victim related that on this occasion the suspect had placed his hand on her "private spot" indicating her vaginal area and had rubbed her vaginal area over her panties. The suspect once again positioned himself on top of the victim and attempted to have sexual intercourse with the victim. On this occasion like the first he was unable to become erect and make penetration.

After the second incident the victim had advised the suspect that what they were doing was wrong and that they needed to stop. The suspect continued to call the victim on her cellular phone until the day of the third occasion when he called and inquired of the victims' location and had related that he was in the area of her residence on . The two arranged to meet at an apartment complex on Highway Y known as the Apple wood Apartment complex. When the victim arrived at the complex the suspect was already parked and upon seeing the victim pull up exited his vehicle and entered her vehicle. The suspect directed the victim to drive to an unidentified gravel road on Highway Y past the area of the victims' residence. Once the victim had parked the car she was directed into the back seat where once again the suspect removed her pants and attempted to have intercourse with her once again. The victim related that on this occasion however that the suspect had a hold of his penis with his hand and was attempting to force it inside the victim. The victim related that to her knowledge that the suspect never achieved an erection during this incident either. When asked if he had made any penetration into her vaginal area the victim was uncertain if he had entered any part of her but stated again that he kept rubbing his penis against her "private spot". The victim was asked if on any of the three occasions the suspect had placed his mouth on any part of her body to which she stated that all he had doe was kiss her on the area of her neck. It was inquired of the victim if during any of the three occasions had the suspect requested of her to place any part of his body into her mouth to which she related "no". When asked if during any of the three occasions had the suspect attempted to or had he placed any other part of his body inside of her private spot, the victim related that on the second occasion that the suspect had rubbed her private spot with his hand.

The audio interview was concluded at this point after once again having relate that the interview was a voluntary interview on her part and that it in no way was forced upon her.
