<p>Jack Collins, SB, came into Central Precinct to report he had molested [redacted]. He told me he rubbed his penis on her vagina. He said he couldn't remember when it happened but thought it happened in his parent's house. He said he did this when he was in high school but couldn't remember exactly how old he was when he did it. I asked Collins what [redacted] name was, he said he thought it was [redacted] but wasn't sure. He said he didn't know how old she was or where she lived. He didn't even know in which state she resides now. Collins said he hasn't had any contact with [redacted] since the incident.</p> <p>Talking with Collins was difficult as he took quite a while to respond to questions and had to be reminded periodically of the question. He acted as if he didn't understand several of the questions I was asking. I checked PPDS for the name [redacted]. I found a [redacted] with an address in [redacted]. The original date on that PPDS entry was 1998. After speaking with Collins for a short time he asked if he could get mental health care. I directed him to Cascadia Mental Health. At this point, after speaking with Collins, I do not believe a crime actually occurred. If it did, the statute of limitations has long since expired.</p>
