duke dukeadk (11/16/2007 12:04:21 PM): i would like to make you cum

Cin (11/16/2007 12:07:33 PM): how come u dont have a pic in yur profile?

I was in Missouri chat room 4 when "duke dukeadk" sent a whisper asking if Cin lived in Diamond. I was busy with others at the time and gave him Cindy's email address and he continued to chat without any response from Cindy.



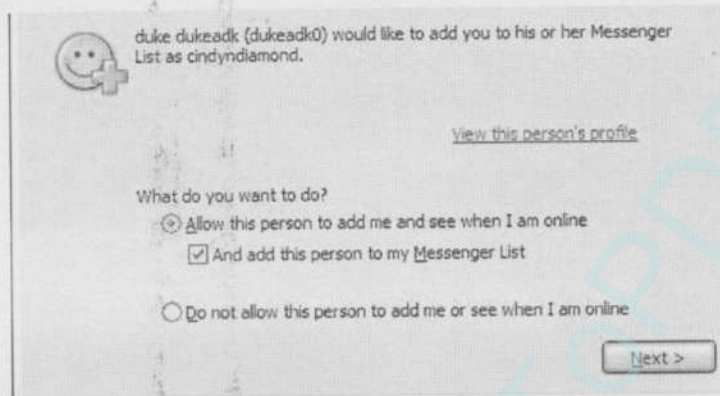
Duke then invited Cindy to add him to his Instant Messenger:

On November 16, Duke initiated an Instant Message and stated,

**duke dukeadk (11/16/2007 11:44:24 AM): hey you forgot to ask how old i am before you added me to you list lol**

and stated that he was 55. Cindy told him:

**Cin (11/16/2007 11:45:35 AM): i am 13/ female/ and live near Joplin**

Cindy stated that she liked French kissing and Duke responded:

**Cin (11/16/2007 11:47:22 AM): i like to french kiss... senior boy taught me.**

**duke dukeadk (11/16/2007 11:47:55 AM): but it depends on where you want to be kissed at lol**

**Cin (11/16/2007 11:48:07 AM): ohhhh, well, you pick the spot! lol**

**duke dukeadk (11/16/2007 11:48:24 AM): does it have hair around it lol**

Duke asked Cindy:

**duke dukeadk (11/16/2007 11:52:49 AM): so you a virgin**

Duke expressed concern that Cindy might be law enforcement:

and later asked the question:

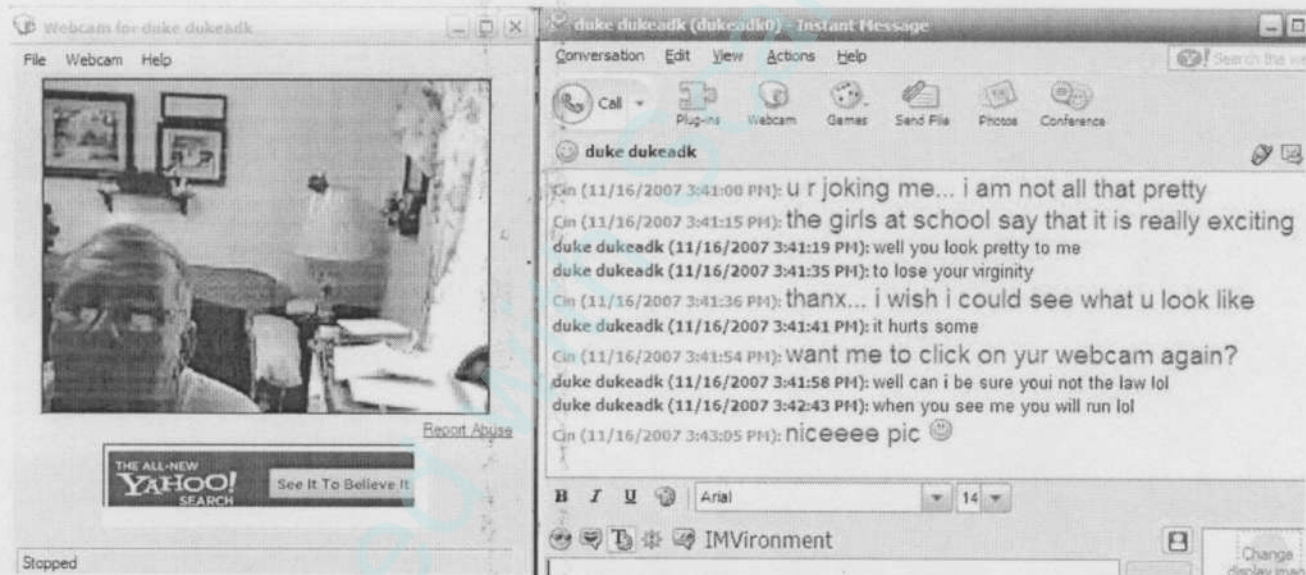

duke dukeadk (11/26/2007 7:10:30 PM): again  
Cin (11/26/2007 7:10:53 PM): yes i remember that... 13 ... but will be 14 in december... how old r u ?  
duke dukeadk (11/26/2007 7:11:08 PM): im 55 sorry

Duke then asked: duke dukeadk (11/26/2007 7:12:00 PM): are you a virgin

Duke instructed Cindy how to masturbate:

**duke dukeadk (11/26/2007 7:15:15 PM): put the shower on your clit and make it hot water lol**  
**Cin (11/26/2007 7:15:29 PM): wow... that would feel good**  
**duke dukeadk (11/26/2007 7:15:50 PM): i wish i could help you with it lol**

Cindy stated that they lived a long distance apart but Duke stated:

**duke dukeadk (12/1/2007 8:29:17 AM): it would be worth the drive if i got to make love to you**

When Cindy asked Duke if he would bring condoms, he stated:

**duke dukeadk (12/1/2007 8:32:12 AM): no im sterile can get you preg**

Duke stated that he would show his penis:

**duke dukeadk (12/1/2007 11:53:51 AM): i dont have pics but i got a cam ill show it to you some time**  
and,

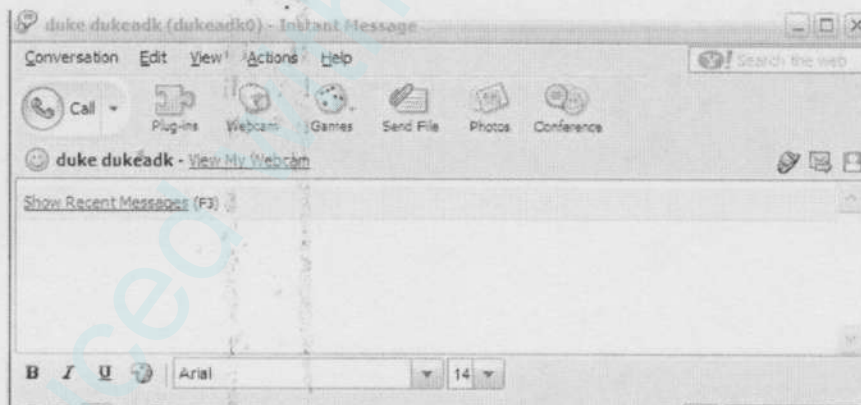

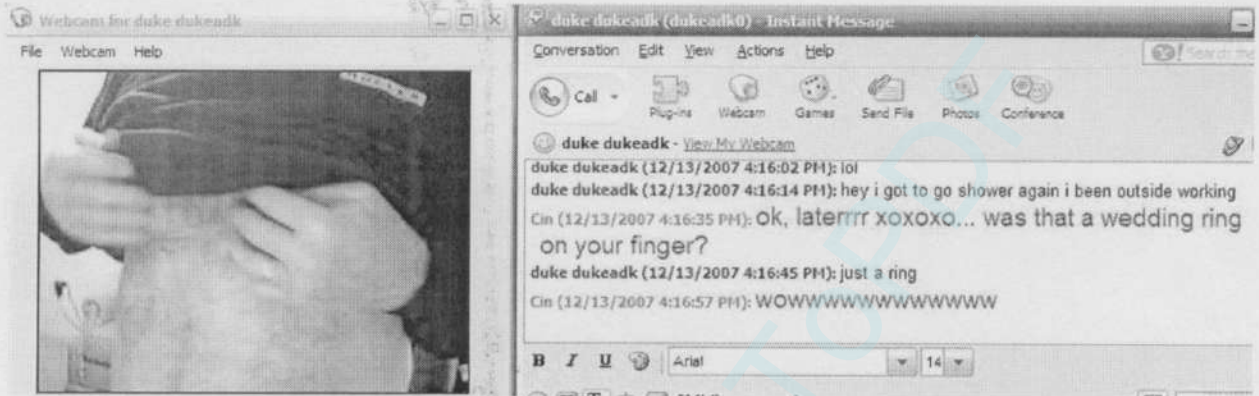

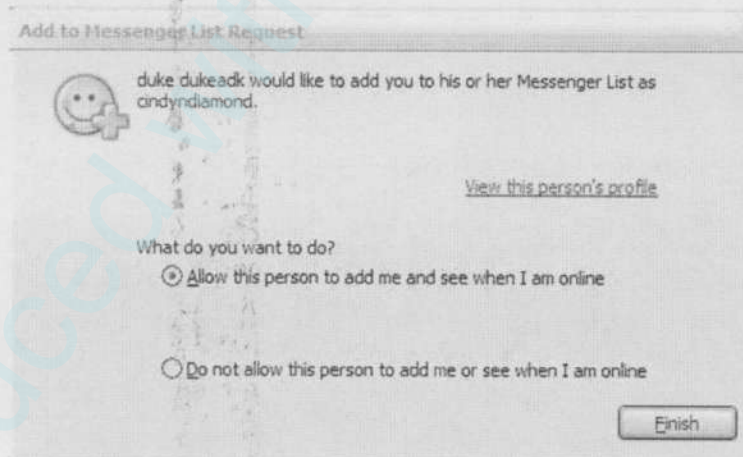
**duke dukeadk (12/13/2007 4:17:28 PM): theres more when you geet a cam**



On December 26, Duke logged onto Yahoo Instant Messenger at 2:23 PM Central Time. He inquired about Cindy's webcam. Cindy had sent Duke an offline message on December 25 stating that she had obtained a webcam for Christmas.

**duke dukeadk (12/26/2007 2:25:19 PM): so you get a cam for christmas**

Duke stated that the reason why he had not been online was because "just havent been on is all." Duke stated that he had lost his Instant Messenger contacts and asked Cindy to accept him a second time:



On December 1, 2007, Duke stated that he had worked with an insulation company in Joplin:

**duke dukeadk (12/1/2007 8:30:54 AM): ok i know joplin**

**Cin (12/1/2007 8:31:11 AM): ok, i dont know many people in joplin**

**duke dukeadk (12/1/2007 8:31:23 AM): i worked there for a while**

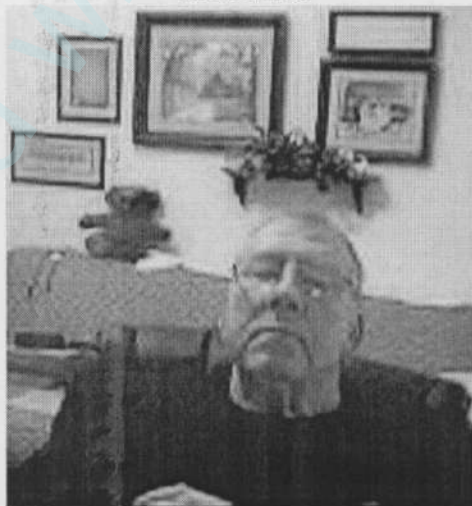
