Comes now Officer Chad Stiefeman states the following under oath:

1. I have probable cause to believe the defendant committed the crimes of Furnishing Pornographic Materials to Minors (RSMo. 573.040), and Sexual Misconduct Involving a Child (RSMo. 566.083) in that on or about 1442 hours on 03/21/2007 at 401 Monroe Street, Jefferson City, Missouri, County of Cole.

2. The facts supporting this belief are as follows:

On the dates of 3/21/2007, 3/23/2007, 4/9/2007, 5/4/2007, 5/30/2007, 6/21/2007, 6/26/2007, 7/5/2007, 7/9/2007, 7/18/2007, 7/31/2007, 8/27/2007, 8/28/2007, 9/19/2007, 9/26/2007, and 1/7/2008 the defendant committed the crime of sexual misconduct involving a minor by knowingly exposing his genitals to a child less than fourteen years of age for the purpose of arousing or gratifying the sexual desire of himself and/or the child.

On 7/30/2007 and 8/27/2007 the defendant committed the crime of Furnishing Pornographic Materials to Minors by knowingly furnishing material that were pornographic for minors, via a computer web cam and the Internet knowing that the recipient was a minor.

On 3/21/2007 I was masquerading in a Yahoo chat room as a thirteen year old female. I was sent an unsolicited chat invite from user dukeadk0, later identified as the defendant. Four minutes into the chat I told the defendant that I was only thirteen years old. The defendant and I had 120 chat communications since that date. During the additional chats I made statements and communications that clearly reminded the defendant that I was a minor. On the above listed dates the defendant invited me to view his web cam. He then exposed his genitals to me via the web cam [REDACTED]. He also requested that I [REDACTED] while watching him. On 7/30/2007 the defendant walked me through the internet step by step and showed me how to find pornographic movies to watch. After finding the web site ultrasexmovies.com he had me click on the link to the free sample. It displayed a white male adult and a white female adult having sexual contact. On 8/27/2007 the

defendant used his web cam to play a movie on his computer for me to see of a white male adult and a white female adult having sexual contact before he exposed himself.

On 9/19/2007 the defendant allowed me to see his face while broadcasting his web cam to me. I was able to capture the image and compare it to a Department of Revenue Photo. With the comparison I was able to positively identify the defendant.

On 1/15/2007 I spoke with the defendant on the phone and he advised that he know that I was only thirteen years old and that what he had shown me on the web cam was wrong. He said that he is the only person that has chatted with me using his account. He said that he was portraying both of the individuals that had been using the account to speak with me.

3. I further believe that the defendant:

- a. Will not appear in court in response to a criminal summons because: **N/A**
- b. That the defendant poses a danger to a crime victim, the community or any other person because: **N/A**.
