

PROBABLE CAUSE STATEMENT

I, Deputy Clinton A. Lee, am a law enforcement officer for the Webster County Sheriff's Department. I have been a law enforcement officer for five years. I, upon my oath, and under penalties of perjury, state as follows:

1. I have probable cause to believe that Jessie Franklin McCormick, DOB: 06-22-87, SSN: 512-96-6745, Male/ White, 5'7", 173lbs, Brown hair, Brown eyes, of US Army (3231 Gate St Unit 7041, Ft. Leonard Wood, MO 65473), committed one or more criminal offense(s).

CRIME: Statutory Rape in the first degree (Class felony)
COUNT ONE: Between 06-01-2007 and 12-31-2007
COUNT TWO: Between 06-01-2007 and 12-31-2007
COUNT THREE: Between 06-01-2007 and 12-31-2007

2. The facts supporting this belief are as follows:

On 01-01-2008 at approximately 1030 hours myself and Deputy Aldridge were dispatched to 4690 Old Jericho Road Seymour Missouri within Webster County in reference to trespassing. Upon our arrival I made contact with [REDACTED] the father of K. L. W., his thirteen year old daughter. [REDACTED] stated that his daughter along with another juvenile later identified as A.L.W. a fourteen year old female and three or four male subjects were on his property. [REDACTED] stated that one male subject later identified, Jessie Franklin McCormick, had been warned not to come on to his property by [REDACTED]. [REDACTED] stated that he believed that Jessie was having sexual intercourse with his thirteen year old daughter K.L.W.

We searched the property and located five individuals inside of a silver Saturn passenger car in a wooded area on [REDACTED] property. We ordered all subjects to the ground. All subjects got on the ground except K.L.W. K.L.W was taken to the ground and placed in handcuffs. The other four subjects were also taken into custody.

During the course of our investigation Jessie McCormick made the following statements. Jessie stated that he inserted his finger into A.L.W.'s vagina on 12-31-2007. Jessie stated that he had sexual intercourse with K.L.W. on seven separate occasions within the last six months. Jessie McCormick filled out a voluntary statement form, which is attached to my report. Jessie was booked into the Webster County Jail on a twenty-four hour investigative hold for statutory rape.
